Under the present policy of decentralized system of considering extension of approval and based on the recommendations of State Level Committee for the State of Maharashtra, the All India Council for Technical Education hereby agrees extension of approval / approval for introduction of additional courses / variation in intake, as applicable, in respect of your institution for the academic year **2010-11** to conduct the following courses and the intake mentioned below:-

## ANNEXURE - I

The approval accorded above is subject to fulfillment of the following conditions:-


1. Principal & faculty qualified as per AICTE Norms should be appointed before making admissions with revised AICTE scales (6<sup>th</sup> Pay) & other allowances like State Government D.A., H.R.A. etc.
2. Admissions shall be made through as per the Policy & Guidelines of the Govt. of Maharashtra only.
3. All the required Laboratories / Workshops / Machineries / Equipment as per approved syllabus of the Maharashtra Board of Technical Education must be operational before making admissions.
4. No excess admission shall be made by the Institution during any academic year.
5. The approval is valid only for the academic year as mentioned in the table. If no further extension of AICTE approval is received beyond the academic year, this Approval Letter will not be valid for making any admission for the subsequent years.
6. Name of the Institutions, Name of the Society/ Trust, is not allowed to change without prior approval of AICTE. The name and title of the institutions should be such that "the Emblems and Names (Prevention of improper use) Act (1950)" of Government of India is not violated in any manner.
7. Any other condition(s) as may be specified by AICTE from time to time.

Consequent to the Supreme Court Judgment, the Model Constitution of Governing Body notify by AICTE in its approval Regulations 1994, stands overruled. It has been decided that while AICTE will not insist on any nomination in the Governing Body of Private Unaided Institutions, the Affiliating University/ State Government shall impose minimum conditions of affiliation, such as prescription of qualifications of Governing Body Members, in order to ensure academic excellence. It shall be desirable for the private unaided institutions to induct at least 50% of the Governing Body drawn from renowned academic, academic administrator, subject Experts and professionals from industry, in order to seek their innovative ideas for continuous improvement in the delivery of teaching learning process, matching best practices else wise and achieve excellence.

In exercise of power conferred under 10(p) of the AICTE Act, AICTE, may inspect the institution any time, if it may deem fit verify the process / compliance or for any other purpose.

In the event of infringement / contravention or non-compliance of the above conditions and / or the provision of AICTE, Act & Regulations / Guidelines / norms & standards as prescribed by AICTE, further actions leading to 'Reduced Intake' "No Admission of Approval, may be taken by AICTE and the liability arising out of such actions will be solely that of the Management of the Institutions."

3. Internet facility should be made available.
4. Copy of Compliance report should be submitted to AICTE, Western Regional Office, Mumbai as well as to Director of Technical Education. (Maharashtra).
5. The institution has to submit the following particulars :-
  - a) Name, full address, Phone/ Fax Nos. of the Trust along with the name of the Chairman / Secretary.
  - b) Name, full address, Phone / Fax Nos. of the Institution along with name of Principal and his Bio-Data with his photograph.
